- The Greenhouse Gas Emissions with WPG Holdings Limited for the period from 2022-01-01 to 2022-12-31 was verified, including direct greenhouse gas emissions 1,065.517 tonnes of CO₂ equivalent and indirect greenhouse gas emissions from imported energy 6,168.087 tonnes of CO₂ equivalent.
- No material misstatements for the period from 2022-01-01 to 2022-12-31 Greenhouse Gas Emissions calculation were revealed.
- Data quality was considered acceptable in meeting the principles as set out in ISO 14064-1:2018.
- The emission factors of electricity in the organization's GHG report for the year 2022 are 0.509 (Taiwan, 2021), 0.420 (Shanghai, 2022), 0.570 (Shenzhen, 2022), 0.730 (Suzhou, 2020), 0.687 (Beijing, 2020), 0.605 (Dongguan, 2020), 0.390 (Hong Kong, 2021), 0.411 (Korea, 2022), 0.406 (Singapore, 2021) kgCO₂e/kWh, while the citations of different electricity factors may result in different GHG emissions estimates.
